# Stage 2 VBYLD - Essay Rounds - Concept Note

#### A. Overview

- 1. The winners of Quiz will be announced on 6th November, 2025. 10% of the Participants (not more than 3 lakh) selected from the Quiz round will proceed to stage II Essay round.
- 2. After qualifying through the **Viksit Bharat quiz**, participants will submit a 500-1000 word essay on one of the **10** key themes of the **Viksit Bharat Challenge**. Essay writing will be hosted on MY Bharat portal.
- 3. The Themes for Viksit Bharat Challenge Round are:
  - a. Youth in Democracy and Government for Viksit Bharat
  - b. Women Led Development: The Key to Viksit Bharat
  - c. Fit Bharat Hit Bharat
  - d. Making India the Start Up Capital of the World
  - e. Bharat's Soft Power: Cultural Diplomacy and Global Influence for Viksit Bharat
  - f. Innovation with Tradition: Building a Modern Bharat
  - g. Aatmanirbhar Bharat: Make in India, Make for the World
  - h. Enhancing Productivity through Smart and Sustainable Agriculture
  - i. Building a Sustainable and Green Viksit Bharat
  - j. Building a future ready work force for Viksit Bharat
- 4. Once chosen the theme cannot be changed for the subsequent rounds. The Essay evaluation will be done from **21st November**, **2025 27th November**, **2025** at a venue determined by the State / UT Government.
- 5. In order to encourage participation of youth from rural and remote areas, the participants shall be encouraged to utilize the facility of **Common Services Centre** under Ministry of Electronics and Information Technology (MeitY) for taking part in Viksit Bharat Essay (Stage II), apart from the quiz.
- 6. The results of the Viksit Bharat Essay Round will be announced on **28th November**, **2025**. The top **10% of essay submissions from each State/UT**, across all 10 tracks, will be selected to move forward to the State Championship round. A maximum of **500 participants**, up to **50 from each track**, will be shortlisted for this round.
- 7. Evaluation of Essays will be done by domain experts at designated University centres determined by the State / UT Government. The Assessment Matrix for Essay evaluation is at Annexure-A

### 2. Implementation of Scoring

- a. **Weightage**: Assign points based on your assessment matrix (e.g., Content Quality: 30%, Structure: 20%, etc.).
- b. **Total Points**: Multiply rubric scores (1-5) by corresponding weightage for each criterion.
- c. **Example**: If an essay scores:
  - i. Content Quality:  $4/5 \rightarrow 24/30$
  - ii. Structure:  $3/5 \rightarrow 12/20$
  - iii. Originality:  $5/5 \rightarrow 15/15$
  - iv. Clarity:  $4/5 \rightarrow 12/15$
  - v. Evidence:  $3/5 \rightarrow 6/10$
  - vi. Conclusion:  $5/5 \rightarrow 10/10$
  - vii. Total: 79/100

#### 5. Educational Qualifications

- a. Academicians: Applicable to Knowledge for Nation-Building
- b. Policy Experts: Applicable to *Policy Innovation for Inclusive Growth*.
- c. Industry Experts: Applicable to *Driving Development through Innovation and Enterprise*.
- d. Development Professionals: Applicable to *Empowering Communities for Sustainable Progress*.
- e. Domain Specialists: Expertise for Excellence and Innovation
